NOTES ON SERVICE REQUESTS FOR LICENSES: Software licenses are requested under the same service type and function as the eligible Category Two Internal Connections equipment they support. Access point licenses are requested under Service Type: Internal Connections and Function: WAP; firewall licenses are requested under Service Type:Internal Connections and Function: Firewall Service and Components.

LICENSE RENEWALS FOR EXISTING LIBRARY-OWNED EQUIPMENT: The library should include the manufacturer (make) and model information for the equipment that needs a new license, but the language 'or equivalent' must still be included in the narrative (the Form 470 automatically adds the phrase, 'or equivalent' to Internal Connections service requests when a Manufacturer preference is indicated). While it may seem odd or unnecessary to include this language, E-rate program rules require applicants to consider proposals for alternate services or products that provide the same functionality.

LIBRARY BACKGROUND INFORMATION: Pioneer County Public Library has 1 eligible entity for Category Two services, its main branch at 100 Main Street, Boonesburg KY 41700.BID EVALUATIONS: All bids must include the Service Provider Identification Number (SPIN/Form 498 ID) or the bid will be disqualified. The Library reserves the right to adjust quantities prior to purchase. The Library has tax-exempt status and will provide documentation to the winning bidder upon request. SPECIFICATIONS:
