In Support of the City of Covington's Grant Application

Dear Ms. Halbmaier,

The City of Covington has, on two separate occasions, formally solicited competitive bids for Microfilm Reader/Viewer equipment, for which it has applied to KDLA for grant funding to acquire.

In its first solicitation the City was careful to include "Or acceptable equal" language to clearly communicate the City's intent and purpose to achieve open, fair and equitable competition. The result was receipt of a sole bid for the ST Imaging brand ViewScan 4 (make & model used as the basis to solicit competitive offers).

In its second solicitation, the City provided more explanation of its intent to receive for consideration competitive offers for competing makes & models of equipment by highlighting specific language that provided detailed explanation of the common and accepted practice of using name brand specifications coupled with the term "or acceptable equal" in public procurement. This detailed explanation was not only highlighted, but also repeated. The result was receipt of a sole bid for the ST Imaging brand ViewScan 4 (make & model used as the basis to solicit competitive offers).

In both instances, the City's formal bid solicitation exceeded usual and customary procurement practices to comply with State of Kentucky Revised Statutes ("KRS"), for which the threshold requiring formal sealed bidding is presently \$40,000.

Attached, please also find a letter from Matt Anderson, Vice President of Sales and marketing for ST Imaging, dated 2023 Oct 25, in which Mr. Anderson stipulates that ST Imaging's market strategies, tactics and related corporate policies result in BP Imaging, the sole bid responder to both City of Covington formal bid solicitations, being the sole source for this brand of equipment in the Covington, Kentucky region.

If there is anything further that I am able to do to facilitate KDLA's consideration of the City's grant application, please be certain that I will. While this is a relatively small cost acquisition for the City, it's value far exceeds its overall cost. Successfully achieving KDLA's grant is, therefore, a personal and professional objective.
