Hello Mr. Frazer,

Thank you for submitting a FY24C2 Local Records Program Grants application for the preservation of your public records.

I am sending this correspondence as a courtesy. As submitted, the application will not move forward to the Local Records Grant Review Committee because there are missing required application documents.

There is time to modify/update the application as the official FY24C2 application close date is September 8, 2023.

The Codification Invitation for Bid Proposal and the Codification Invitation for Bid Proposal Attachment (attachment) were not included in the application. The attachment should specify the records (ordinances, date span and series number), and what the office requires (number of copies, format of copies, etc.). Also, there is no advertisement included in the application.

The bids are different: one specifies five bound copies; one specifies three bound copies; and one specifies online hosting (which is not allowed). Each bid must match the others (regarding the work specified/requested). Additionally, the requested funds (in the application) do not match either bid. Grant awards are made based on the lowest bid vendor cost; we do not recommend an estimated or rounded-up amount for funding approval.

The bids should also be dated. I cannot locate a date on the Municode/CivicPlus bid.

Review the Local Records (LR) Grant Guidelines, page 8. LRGrantGuidelines

Please also be mindful that some vendors specify that the bid (quoted) amount is valid for a certain number of days (thirty (30) days, sixty (60) days). Funding decisions will not be made until December and the award will be made at the lowest bid amount in the application. If the lowest bid amount changes between application submission and the funding decision, the award may not be increased. The local agency will be responsible for the difference.

If you have questions, please let us know. You can submit an updated application at your convenience, prior to or on September 8.
