
**Children's Circulation Per Capita**














### Average Open Hours Per Year - All Outlets




### Full-Time Equivalent M.L.S. Librarians Per 10,000 People




### Full-Time Equivalent Professional Staff Per 10,000 People




### Full-Time Equivalent Library Staff Per 10,000 People






### Local Government Revenue Per Capita




### State Government Revenue Per Capita




### Non-Government Revenue Per Capita




### Print Materials Expenditures Per Capita


### Total Materials Expenditures Per Capita




### Salaries Expenditures Per Capita








### Operating Expenditures Breakdown





## Physical Materials Breakdown



### Notes on using these charts:

1. These charts are only as valid as the data provided by each library.
2. Not all these charts will be meaningful for your library or for libraries in some states. Inconsistent or incomplete data will affect the validity of the charts.
3. Average Annual Hours will be significantly larger for libraries with branches and bookmobiles.
4. All per capita calculations "are based on the total unduplicated population of legal service areas (instead of the total population of legal service areas) in order to eliminate duplicative reporting due to overlapping service areas."
5. Please note that data from libraries on reference transactions, registered borrowers, library visits, and internet sessions are the least reliable of the existing use measures.
6. This resource will be updated as soon as the next data files are released for the Public Library Survey.
7. This resource was created for Connecticut public libraries, but can be used by any public library in the United States.
