Construction Begins on New State Records Center

On September 18, 2012, the Kentucky General Assembly Capital Projects and Bond Oversight Committee approved a lease for a consolidated State Records Center to house over 200,000 cubic feet of state agency records. In early March, 2013, ground was broken for this 100,000 square foot facility, with completion expected before the end of 2013. The new Records Center will have more effective climate control and taller shelving than the current facilities, with state-of-the-art records tracking system and room for expansion.

The Kentucky Department for Libraries and Archives (KDLA) has been offering highvolume, low-cost storage through its records center since 1982, providing agencies with efficient and professional records services while saving millions of dollars for those agencies in records storage costs every year. The need for a larger facility in order to provide the best service possible has been a constant issue for KDLA. Μv predecessor, Richard N. Belding, expanded the records center to a second location, and continued to submit requests for a new records center facility throughout his twentyone year tenure as State Archivist and Records Administrator. Richard's efforts formed the basis of this final and successful request for a consolidated facility.

After construction is completed, State Records Center Supervisor Steve Shackelford and his staff will begin moving records from the two current facilities into the new one, throughout 2014 and into 2015. We anticipate that the move will take place over an eighteen month period, moving from both the facility on East Main Street (rented since 1962 as the first State Archives building) and the Buffalo Trace location.

This is a great step in Kentucky's archival and records management program, allowing KDLA to provide a larger and better facility for storing state agency temporary records.

Research Opportunities at the State Archives: Hatfield/McCov Feud

In May 2012, the History Channel broadcast a threepart miniseries "Hatfields & McCovs," starring Kevin Costner as Devil Anse Hatfield and Bill Paxton as Randall McCoy. The miniseries set the record as the most-watched entertainment telecast in the history of basic cable. Although it's important to remember that the miniseries was indeed entertainment and not a documentary, the producers did contact the Kentucky State Archives in an effort to gather historical information to make the film as authentic as possible. KDLA provided some valuable and, in many cases, unique documentation of the feud, using the public records available in the Archives.

KDLA does not have a specific "Hatfield/McCoy" collection, but several larger collections of public records contain information concerning the feud. These include the official papers of the Kentucky governors who served during this period and judicial records from the Court of Appeals and the Pike County Circuit Court. (The McCoys lived mostly in Pike County, while the Hatfields lived across the state line in West Virginia.)

The papers of Governor Simon Bolivar Buckner (1887-1891) contain considerable documentation of the feud, including telegrams between Buckner and the Governor of West Virginia regarding the advisability of calling out the state militia to quell the violence on both sides of the border, and numerous letters from concerned citizens reporting outbreaks of criminal activity and asking for help. Buckner's correspondence also contains а handwritten confession, supposedly penned by Ellison Mounts or dictated by him, providing some details on feud activities over a period of years. Mounts, a Hatfield supporter, was the only person on either side of the feud to be executed for his part in the violence; he was hanged in Pikeville in 1890. The death warrant for Mounts, signed by Governor Buckner, is also in the governor's papers.

The judicial records of Pike County, especially the Criminal Court Order Books, contain numerous references to feud participants, with Order Book entries documenting various indictments handed down over the years. Criminal Court Order Book 1 (1880-1885) has several entries for "Commonwealth vs. Cap Hatfield" for murder. and Book 3

Index to Naturalization Records Now Available

Naturalization records are created during the process followed by immigrants to become citizens of the United States, and can consist of certificates of arrival, declarations of intention, petitions for naturalization, affidavits of witnesses, and other related documentation. The State Archives has naturalization records from twenty eight counties in its collection, covering dates from the mid-1800s to the The information in a naturalization early 1950s. record is extremely useful to researchers. А naturalization record can include the immigrant's name, place of birth, last residence, physical description, occupation, and maiden name and names of children, if applicable. Thanks to a generous donation from Donna Stark Thompson and Roberta Padgett, two longtime members of the Friends of Kentucky Public Archives, Inc., these naturalization records have been microfilmed, with the records arranged alphabetically by county and then chronologically. State Archives staff compiled a searchable index to the microfilmed records containing over 16,000 entries, now available in the Archives Research Room. This index allows researchers to locate records through a direct search or by browsing by last name, county, or record type. All search results provide the pertinent microfilm roll number, county, type of record, and page number needed to go directly to a specific record.

The State Archives is very grateful to Donna and Roberta for providing funds to microfilm these records and to KDLA staff for compiling the index and making it easily accessible to researchers. Kari May of the Research Room staff coordinated the indexing project. She will discuss this indexing project at the Kentucky Archives Institute on June 21. (1888-1889) contains similar entries for the offenses of assault and battery and for "confederating." Although these entries give little detail, they do provide documentation of the pervasive violence in the county during this period of the feud.

Several case files from the Court of Appeals, including one involving Valentine Hatfield, contain some fairly extensive information on the feud. An entry for Valentine Hatfield can also be found in the prison register for the State Penitentiary, since he was incarcerated for murder and died there.

The Hatfield/McCoy feud had an impact on the lives of both families for many years, but it also helped perpetuate the stereotype of lawlessness and violence that haunted the Appalachian region for decades, and survives to some extent even today. The records in the State Archives that document the feud can give us a better understanding of the people and events of this historically significant era.
