

# 2025 Annual Report Changes

The following are important additions, deletions, and revisions to the Kentucky Annual Report of Public Libraries for FY25:

## Additions

- Item number J6 Number of Volunteers.  
Definition: Report the number of individual volunteers working at your library during the reporting year regardless of the number of hours they worked. Volunteers include Individuals, Board members, members of the Friends of the Library group, Teen Advisory group members, and any other support groups.
- Item number J7 Number of Volunteer Hours.  
Definition: Report annual totals or estimates. Report the number of hours volunteers work at your library by all volunteers for the reporting year.
- Item number Q5 Website Visits Annually.  
Definition: Report the number of sessions initiated by all users from inside or outside the library to the library website. In Google Analytics: Audience/Overview/Sessions  
**Note:** Survey question was used through FY23, not used FY24, and returned to use FY25.
