NOTES ON SERVICE REQUESTS FOR WAP AND WIRELESS CONTROLLER: The Internal Connections function 'WAP' includes both the wireless access point hardware and the software license that may be required to operate certain brands/models (ex: Meraki access points with 'Cloud Controller' subscription licenses; Fortigate access points with 'FortiCloud' subscription licenses). The Internal Connections function 'Wireless Controller' includes a dedicated access point management device installed on a local area network (ex: Ubiquiti Unifi access points can be managed by a 'Cloud Key' controller device). If your library accepts a bid for a solution involving a wireless controller device and the function 'Wireless Controller' wasn't listed on the Form 470, your library cannot request discounts on the Form 471 application for the cost of the wireless controller. Listing both Internal Connections functions (WAP and Wireless Controller) on the same Form 470 helps 'cover the bases' to reduce potential issues during application review. Your library can accept the bid for the most cost-effective solution and help ensure that either function can be listed on the Form 471 application. LIBRARY BACKGROUND INFORMATION: Pioneer County Public Library has 1 eligible entity for Category Two services, its main branch at 100 Main Street, Boonesburg KY 41700. Proposed equipment will be purchased during Funding Year 2021 (July 1, 2021 to June 30, 2022) pending an E-rate funding commitment. Proposed equipment will replace 2 existing access points and add an additional access point to improve Wi-Fi coverage at the main branch. BID EVALUATIONS: All bids must include the Service Provider Identification Number (SPIN/Form 498 ID) or the bid will be disqualified. E-rate eligible costs will be the primary factor in the bid evaluation, but other factors will be considered. Additional points will be given to vendors that will apply SPI/474 discounts to invoices. Pricing should reflect the Lowest Corresponding Price and any discounts available to governmental units. The Library reserves the right to adjust quantities prior to purchase. Vendors are encouraged to schedule a walkthrough of the main branch facility by emailing the Contact Person listed on this Form 470. The last date for walkthroughs will be December 21, 2020 until noon (12:00) ET.

SPECIFICATIONS: Proposed equipment must include any power supplies, licenses, or other components necessary for successful operation. Each line item on the proposal should clearly list quantity, manufacturer, part number, description, unit price, and extended price.

Quantity +/- 3 wireless access points that provide detailed auto-generated wireless usage stats and support Layer 7 firewall rules

Quantity +/- 3 software licenses (length: 5 years) if required to operate the proposed access points

Quantity +/- 1 wireless controller if required to operate the proposed access points

Quantity +/- 500 feet of Cat 6 cabling and any cabling-related materials required to install the proposed equipment Installation of proposed equipment at the main branch (100 Main Street, Boonesburg KY 41700) Shipping, if applicable
