#### Rapid Response

- Demand-driven system offering a pathway to state services for employers and displaced workers
- Layoff Aversion
- Facilitate networking among business services teams and local partners to broker mutually beneficial connections
- Strategic planning, data gathering and analysis designed to anticipate, prepare, and manage economic transition
- Informational and direct re-employment services for workers
- Solutions for businesses in transition, growth and decline

### Rapid response is a pro-active, flexible business-focused strategy designed to:

- Help companies access the resources they need to continue to be successful
- Help companies meet existing and future talent needs
- Provide quick response to announcements of layoffs and plant closings
- Coordinate and provide immediate aid to companies and their affected workers
- Ensure rapid re-employment to minimize the negative impacts of the layoff



#### Worker Adjustment and Retraining Notification (WARN)

1

The WARN Act is designed to provide workers with sufficient time to prepare for the transition between the jobs they currently hold and new jobs.

2

Employers filing an official WARN notice is typically the impetus for starting the Rapid Response process to assist the employees who might be affected.

3

Rapid Response coordinates with the employer to provide information to workers and employers about employment and retraining services designed to help participants find a new job.



#### Rapid Response

- Kentucky Career Center Rapid Response Teams provide statewide, early intervention re-employment services at no cost to companies or their employees affected by layoffs and closings.
- Mandated and funded by federal Workforce Innovations and Opportunity Act
- Rapid Response Teams provide quality, on-site services for an effective and smooth transition to new employment for affected employees.
- Worker Adjustment and Retraining Notification (WARN) legally requires companies laying off at least 50 people to notify state government.






